GENERAL RENTAL CONDITIONS

The rental implies the unreserved acceptance of our general rental conditions, after having read and signed the contract or delivery note for acceptance or acceptance. Where required for access to the rental, a security deposit equal to the commercial value of the entire amount in the rented material will be agreed, to be paid as a bank deposit or cashier's check / bank check or credit card data release in course of validity and proven coverage. credit (see page 3). In any case, to be delivered / communicated in advance by the tenant or by someone appointed on his behalf to collect the material as estimated.

DELIVERY

1 - The material taken over by the tenant or on his behalf is considered accepted or recognized in perfect working order.

2 - The tenant must communicate the date of return of the rented material and any subsequent changes to the same date.

3 - The material is delivered to the tenant at the headquarters of ULTRAANALOGIC, which issues a regular delivery note, a copy of which is returned to ULTRAANALOGIC signed by the tenant or by whoever, on his behalf, is in charge of taking over.4 - Il nolo del materiale decorre dal giorno di consegna.

5 - The transport of the material is always at the tenant's expense and at his own risk.

RENTAL

6 - The rented material can be used in Italy and the tenant undertakes, in case of use abroad, to ask ULTRAANALOGIC for written authorization and the preparation of the related documentation.

7 - The tenant, upon receipt of the material, must take out an irrevocable insurance policy against damage in favor of ULTRAANALOGIC for the value of the rented material, according to the value indicated by ULTRAANALOGIC or resulting from the inventory. The insurance must include all transport risks for cars, trains, ships and planes; all risks for damage due to atmospheric events, accidents, etc. ... including the loss of the rental.

8 - In case of loss, deterioration, theft and / or fire of the rented material, the tenant must notify UL-TRAANALOGIC by registered letter within 24 hours from the moment in which the event occurs. The tenant is responsible for the material up to the value indicated by ULTRAANALOGIC, or inventory in accordance with point 7).

In this circumstance, ULTRAANALOGIC may request immediate compensation for the material from the tenant at any time and withhold the precautionary deposit, excluding payment of the relative rental. If the tenant has fulfilled the obligations preceding the compensation paid or due to UL-TRAANALOGIC by the insurance, the amount of the precautionary deposit will be reimbursed or the damaged material will be considered transferred to the tenant himself.

9 - Any breakdown or breakage of the material during the rental will be repaired by ULTRAANALOG-IC or by the manufacturer of the material itself and charged to the tenant after deduction from the security deposit. The tenant undertakes not to modify, nor to have the rented material modified, not to be repaired, nor to have it repaired, unless otherwise agreed in writing by ULTRAANALOGIC.

10 - The tenant undertakes, remaining at his expense any and all responsibility for the value of the material and the rental, to make known and present to all third party creditors acting for attachment or seizure or other executive or precautionary measure of the rented material, which the material is owned by ULTRAANALOGIC, communicating to it any actions taken by third parties.











11 - In the case of rental of particular material, the tenant must hire a trusted person from ULTRAANALOGIC, with the role of consignee, without prejudice to any liability of the tenant himself, pursuant to Art. 2049 of the Italian Civil Code

12 - The material rented by ULTRAANALOGIC is prepared according to the regulations in force and the tenant who will provide for the installation and connections, even through third parties, must scrupulously observe the safety rules as regards him, assuming all and total responsibility for criminal matters, civil and fiscal. The tenant undertakes, with an insurance policy or by personally responding, to reimburse damage to property or people, employees or strangers, caused by accidents resulting from the rented material or its use.

13 - No rental discount or reduction in the duration of the rental will be allowed to the tenant due to the forced immobilization of the material, neither for reasons of stopping filming nor for delay in production or for any other reason.

14 - For defects or failures of the rented material, even coming from hidden defects, the tenant cannot expect that the pure and simple replacement of the pieces or the piece and, in case of impossibility to replace without delay, the exchange with equivalent material, without right to any indemnity for non-enjoyment of the leased property.

15 - ULTRAANALOGIC assumes no responsibility for delayed deliveries, or malfunctions or total or partial accidents that occur during filming, or likely to cause the arrest of the same, as the rental rates are independent of the value or realization of the shot produced with the help of hired appliances. ULTRAANALOGIC excludes any guarantee and any liability for any direct or indirect damage possibly suffered by the tenant customer or by third parties, as a result of the inefficient functioning of the rented material (damage to film, missed or delayed filming, etc.).

RETURN

16 - The material must be returned in efficient condition, order and perfect condition.

17 - The material must be returned to the ULTRAANALOGIC headquarters.

18 - The freight ends on the day of delivery.

19 - Partial returns of parts of the same appliance are not accepted. The rental days will be calculated up to the full return.

20 - In the event that the appliances are damaged again, the tenant must pay an indemnity equivalent to the rental price.

21 - The material must be returned during the opening hours of the warehouse.

22 - Any delay in the delivery of the material is considered as an extension of the rental itself, subject to compensation for greater damage, pursuant to Art. 1591 of the Italian Civil Code.

23 - Any item missing when the material is returned will be replaced by ULTRAANALOGIC and charged to the customer, at the market price of reference value in the case of used or new objects and / or equipment in Italy.

24 - If the return of the rented material takes place within 12 hours, it is considered terminated the evening of the previous day.

PAYMENT

25 - ULTRAANALOGIC applies in the invoices the prices indicated in its price list and / or agreed with the tenant.

26 - Unless otherwise indicated, payment is intended in cash.









27 - Invoices are issued weekly. Complaints on invoices will not be accepted after 5 days from their issue.

28 - The exclusive competent court is on Milan - Italy.

29 - In case of use, the tax charges are due to the tenant.
